Course Description: This intermediate course is divided into four instructional sections: Section I: Concept and Overview of the Chart Mapper, Section II: Starting with the Chart Mapper, Section III: Constructing a Chart, Section IV: Publishing with Charts.

Learning Objective: To gain knowledge to build a chart and generate style to replicate a client's output. The conceptual knowledge presented will focus on the most common type of chart, the bar chart, but will also provide working knowledge on line and pie charts.
